

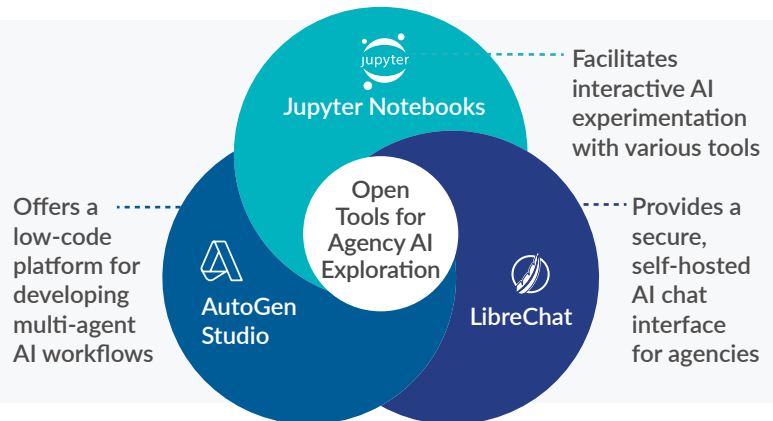

SOLUTIONS

- Simulate multi-agent coordination for processing case files, auditing transactions, or generating reports.

Search and Summarize Structured and Unstructured Data with Generative AI

- Connect AI with internal agency databases to retrieve real-time, fact-based answers.
- Summarize policy documents, legislation, and case studies.

Analyze Data Sources, Identify Trends, and Summarize Reports for AI-Assisted Decision Making

- Conduct on-the-fly data calculations and scenario modeling.
- Model multi-agent advisory systems where AI copilots work together to analyze legislative impact, budget planning, or supply chain risks.

Securely Evaluate LLMs Without Vendor Lock-In

- Test LLMs in a private cloud without sending sensitive data outside the agency.
- Deploy AutoGen workflows inside AWS GovCloud or Azure GCC to ensure compliance with federal security mandates.

Establish Internal AI Governance

- Conduct internal AI risk assessments using RAG-based AI transparency models.
- Run controlled AI accuracy and transparency experiments within AutoGen Studio.

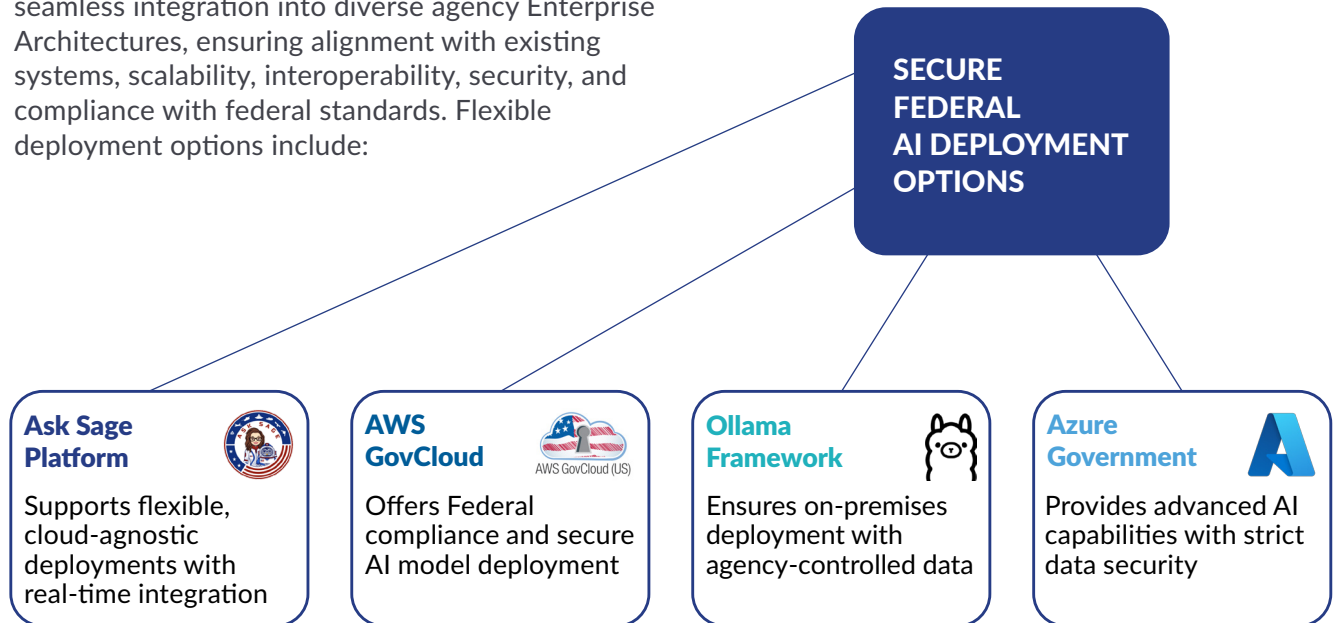
